What is a Conservation Authority?



The Board of Directors (elected and appointed by the municipality) govern Programs that are:

- Mandatory e.g. Flood Forecasting and Development Permits addressing flooding and erosion;
- Delivered per Agreements e.g. Provision of Planningrelated input to municipalities; and/or
- Meeting Local Priorities and Needs e.g. Conservation Areas and Education Programs

GSC will provide water management expertise, including a strong technical understanding of our watersheds supported by modern real-time monitoring and tools

Goal: Enhance GSC Land Management and Natural Heritage Preservation

GSC will work with and align partners and stakeholders on enhancements to conservation lands management, and support municipalities and partners in protecting Natural Heritage core green areas and linkages.

Goal: Support the Development of Watershed Plans with Municipalities

GSC will work with watershed municipalities to promote a broad understanding of watershed plans and best practices for success, and to share leadership in the delivery of the first full watershed plan in our jurisdiction.

Goal: Improve Water Quality

Supported by modern monitoring and tools, GSC will share water quality information and expertise with landowners, municipalities, partners and stakeholders and promote an aligned focus on activities that will make a positive difference.

Goal: Strengthen Environmental Education and Communication

GSC will enhance environmental education so it is more available across the watershed and to all demographics and will implement focused communication that promotes connections with our watershed and GSC's identity.




Under the Planning Act:

- CAs are delegated responsibility by MNRF for commenting on Natural **Hazards**: Floodplains, Shorelines, Erosion prone lands, Unstable soils
- Under MOUs, many CAs provide comments and guidance to municipalities for Natural **Heritage**:
 - Significant fish and wildlife habitat, wetlands, woodlands and valleylands
 - Areas of Natural and Scientific Interest
 - Threatened and Endangered Species

<u>Under the Conservation Authorities Act</u>: GSC has Regulation 151/06, requiring permits for Development, Interference with Wetlands and Alterations to Shorelines and Watercourses.

Specific to the Great Lakes Shoreline the GSCA completed a shoreline management plan in 1994 and assists in review of proposals.



GSCA Permit Process

- The GSCA process is generally the same as SVCA.
- Consultation with our planning and regulation staff is recommended prior to completing any shoreline works.
- Permit application guide and policy document is available on our web site.
- Regulated areas are outlined on our web site. <u>www.greysauble.on.ca</u>
- In water works are subject the Ministry of Natural Resources and Forestry Public Lands Act processes and the Federal Department of Fisheries and Oceans authorizations and/or letter of advice process.

Shoreline Flood/Erosion Warnings Grey Sauble Conservation

- Use Windy application to assist in prediction of wave heights and anticipated potential damage areas on Lake Huron and Georgian Bay. https://www.windy.com/
- Proactive high and low water information monitoring & coordinated response to flood emergencies for riverine and shoreline situations.
- Contacts are made with Municipal staff such as Fire Chiefs, Forepersons, Emergency Management Coordinators, Roads Superintendents and other stakeholders.
- Watershed conditions map with links and data available on the GSCA web site.
